

THE LEGAL STUFF

TERMS:

- 1. Must be 21 years of age to rent.**
- 2. Must have a valid drivers license with motorcycle endorsement. (We require a copy of your license with endorsement). Int'l license accepted with proper motorcycle endorsement.**
- 3. Must have approximately 2 years riding experience on SIMILAR SIZED MOTORCYCLE that you want to rent.**
- 4. Must have a major credit card.**
- 5. A \$1500 hold on your credit card is required at the time of rental pick-up as a damage deposit authorization. NOTE: This is a credit card PRE-authorization ONLY, not a charge, and only to be used in the event of property damage or otherwise not abiding by the rental agreement). This is your maximum liability in the rare event of damage occurring.**
- 6. All renters and riders must sign the company waivers and rental agreements at the time of rental pick-up.**
- 7. Rentals are available May 1 – Oct 31, unless otherwise offered.**

RESTRICTIONS:

- 1. Off roading is strictly prohibited. Our moto's are street bikes. They stay on paved roads.**
- 2. Travel in Mexico is strictly prohibited.**
- 3. Canada travel is allowed. But proper documentation such as passport will be required and is the renter's responsibility.**

4. A motorcycle helmet is required by law in Oregon and most neighboring states. Triple T Riders has helmets available to rent for a small fee (\$6/day), subject to availability.

INSURANCE:

1. Renters **MUST** purchase basic daily rental insurance (@ \$15/day). We provide this through a third party.
2. Supplemental liability ins. is available for an additional \$6.95/day if desired. (Increases liability coverage of third-party bodily injury and property damage).
3. Renter may purchase a reduction in theft and damage liability ("Loss Damage Waiver") @ an additional \$25/day. This reduces the renter's maximum out of pocket liability for theft and damage to the rental unit to only \$750.

PASSENGERS:

1. Passengers are allowed and are covered under the insurance policy at no extra cost, but they must sign the required waivers.

PAYMENT REQUIRED:

1. A deposit equal to 25% of the rental fee is required to be paid up front to secure a rental reservation.
2. Rental balance must be paid in full 30 days prior to rental pickup. Unpaid balances may result in losing your reservation.

CANCELLATION POLICY:

- 1. Cancellations made more than 45 days in advance will be refunded 100%.**
- 2. Cancellations made 21-45 days in advance will be credited 100% to a future rental with Triple T Riders to be used within one year.**
- 3. Cancellations made less than 21 days of reservation are non-refundable.**

STORAGE:

- 1. We are happy to store your gear or belongings for you (within reason) during your rental at no charge.**

PARKING:

- 1. Parking is limited and may or may not be secure at our location. Please contact us if you have specific parking needs for a car, etc.**
